

Terms & Conditions of the Video Submission Competition

Bringing the voice of mining communities and indigenous peoples to Mining Indaba 2025

Eligibility

- Submissions are open to individuals representing mining communities and indigenous peoples, civil society organisations, and activists from across Africa.
- Participants must be at least 18 years old.

Content Requirements

- Submissions should reflect your perspectives on future-proofing mining operations in your community.
- Content must be original and not infringe on any third-party rights.

Submission Guidelines

- **Video Duration:** 3–5 minutes
- **Language Requirement:** Submissions must be in English. We understand that there are many people across Africa that won't be able to express themselves fully in English, we are working with the Mining Indaba team to ensure that building on this year's success, we'll be able to extend participation to Francophone speakers in subsequent years.
- **Deadline:** All submissions must be received by November 24th, 2024, at 12:00 GMT.
- **Submission information:** Please make sure to provide your name, age, place of residency and contact information (WhatsApp and or email) when submitting your input.
- **Submission Methods:** Videos can be shared via WhatsApp (+254 706 569872) [please select the HD option when sharing the video] or WeTransfer.com to community-voices@theimpactfacility.com. You may also choose to share a link to Dropbox, Google Drive, or a similar cloud provider.
- **Entry Limit:** Only one entry per person is allowed.
- **Withdrawal Policy:** Submissions cannot be withdrawn once submitted.

Technical Specifications for Video Submissions

- **File Type:** Recommended formats include MP4 or MOV.
- **Resolution:** A minimum resolution of 720p (1280x720) is recommended to ensure clarity.
- **Quality:** While we encourage creativity and personal expression, submissions must meet a minimum quality standard. Insufficient quality may limit our ability to use the material. Average smartphones are typically capable of achieving these specifications.

Selection Process and Event Access

- A panel of reviewers will evaluate submissions, and up to three individuals will be selected to attend the MI25 event in person, with travel and accommodation covered, subject to budget limitations.
- Please note: The Impact Facility will help with the provision of a invitation letter for visa purposes, but cannot guarantee that selected individuals are able to get their visa to enter the country.
- Travel will be booked in economy class through The Impact Facility, and an allowance for food and board will be provided.
- Winners will be contacted by the organisers before November 30th, 2024.
- Selected winners may be considered for a contribution to the programme as panelists. The selection of these individuals is at the discretion of The Impact Facility, and no legal claim exists regarding selection.

Disqualification: The Impact Facility reserves the right to disqualify any submission that does not adhere to these terms or is deemed inappropriate or offensive.

Rights and Usage

- By submitting your content, you grant The Impact Facility a non-exclusive, royalty-free, worldwide license to use, reproduce, modify, publish, and distribute your submission for promotional and educational purposes related to the MI25 event.
- You retain ownership of your content but acknowledge that it may be used publicly.
